One sidewalk will be open at all times, alternating between the north and south sides as the crane moves across the bridge.

Cyclists crossing the bridge will need to dismount and walk their bikes across the bridge.

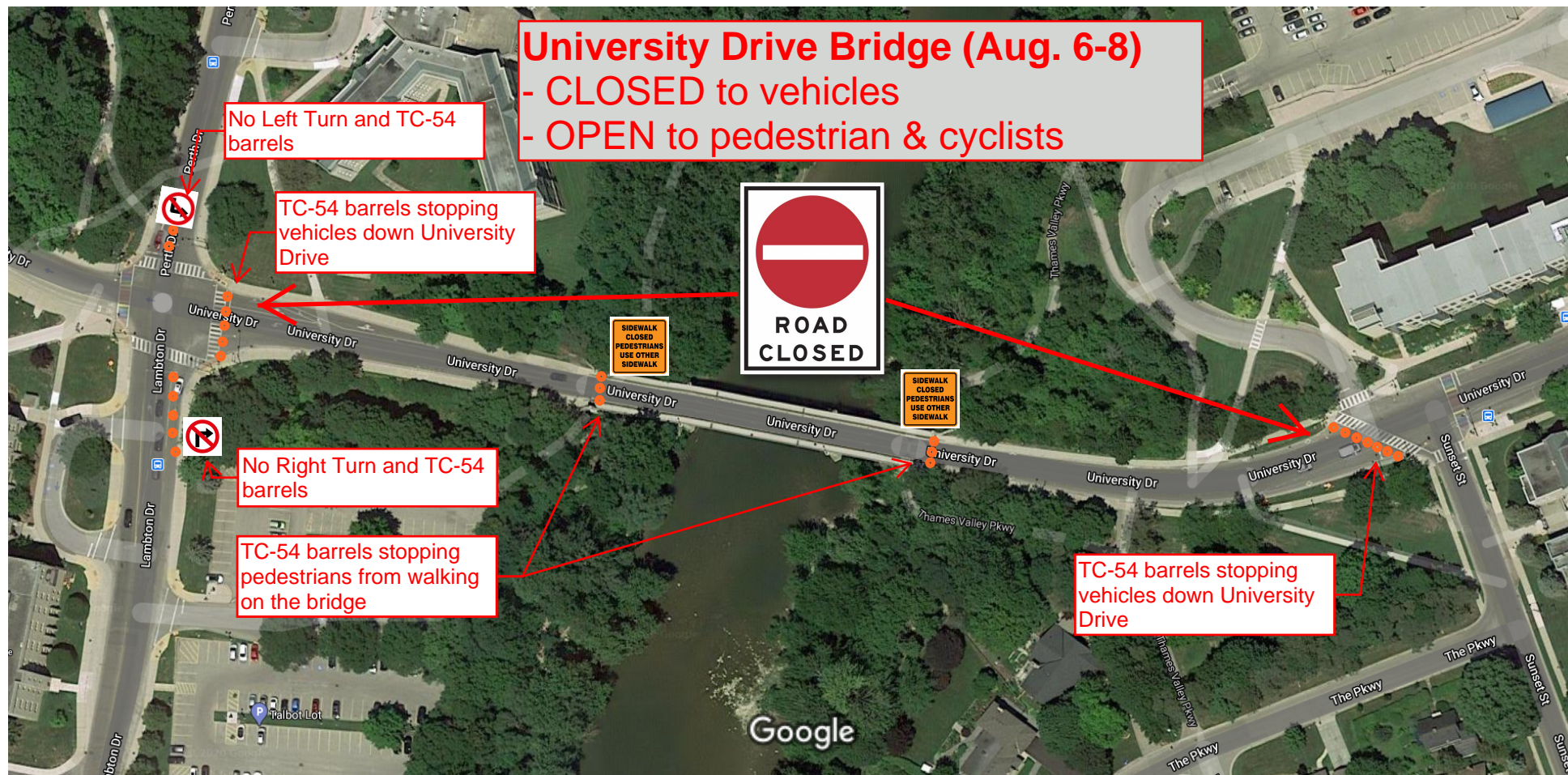
