Course Description: Pricing and Reserving for Short-Term Insurance Coverages, Selection, calibration, and validation of parametric models for insurance losses; credibility theory.

This course covers part of the materials required by SOA's FAM and ASTAM exams.

SS3858A/B A minimum mark of 60% in Statistical Sciences 3858A/B. Restricted to students enrolled in any Actuarial Science module, or those registered in the Honours Specialization module in Statistics or the Honours Specialization in Financial Modelling module.

3. University Accreditation Program – Canadian Institute of Actuaries (CIA)

Honours Specialization in Actuarial Science

If you graduate from Western with an HSP in Actuarial Science, this course will be one of the courses that you will take in your program that will allow you to be exempt from the preliminary exams of the Society of Actuaries (SOA). If you plan to become a fully qualified actuary working in Canada, then all you would need to do is graduate from your HSP in actuarial science and you would then be eligible for the CIA Capstone Exam. Taking and passing this exam, along with completing two online modules and a practice education course, would make you eligible to become an ACIA (Associate of the Canadian Institute of Actuaries).

Major in Actuarial Science

If you graduate from Western with a major in Actuarial Science, the CIA accreditation program will not apply to you. If your plan is to become a fully qualified actuary, then you will need to continue to write and pass the preliminary exams of the SOA. Please see the following link for full details:

Technical Requirements

SOA-approved non-programmable calculators are required for the midterm tests and the final exam.

5. Methods of Evaluation

Assignments

Some practice questions will be assigned in class to help students understand the material. These questions are important in the preparation for the midterms and the final exam.

Loss Reserving/ Pricing Project

For this project, students are required to implement several approaches for loss reserving and risk classification. The report will be marked and counts for 15% of the course grade.

Midterms or Tests

Two midterm tests will be given on **October 14** and **November 13**, respectively, during regular class time. The first midterm is 50 minutes long, and the second is 110 minutes. The midterm tests and the final are all cumulative.

Final Exam

The date and time for the 3-hour final exam will be announced by the registrar's office, usually near the first part of November. Students are required to wait until the final exam schedule is posted before planning for travel over the Christmas period. Exams will NOT be moved to accommodate students who ignore this requirement.

Both the midterm and the final exams are closed books. The overall course grade will be calculated as listed below:

Midterm Exam 1	15%
Midterm Exam 2	30%
Loss Reserving/Pricing Project	15%
Final Exam	40%

SOA-approved non-programmable calculators are allowed for the midterm tests and the final exam.

General information about missed coursework

All requests for Academic Consideration must be made within 48 hours after the assessment date or submission deadline.

All Academic Consideration requests must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, the policy allows students to make one Academic Consideration request without supporting documentation in this course. This is referred to as 'academic consideration request without supporting documentation'. However, the examinations scheduled during official examination periods (Final Exams) are excluded from this, and therefore always require formal supporting documentation.

When a student *mistakenly* submits their one allowed Academic Consideration request **without supporting documentation** for the assessments listed above or those in the **Coursework with Assessment Flexibility** section below, the request cannot be recalled and reapplied. This privilege is forfeited.

Keep in mind that it is advisable for students to write the exams on the date and time they are scheduled unless you really are sick and unable to write.

With this in mind, here is information about what to do if you miss any of the required work in this course:

a) Project:

- Students may use an Academic Consideration request (as long as it has not already been used for Midterm 1)
- OR they can provide documentation to academic counselling

- Those using an Academic Consideration request, or with counseling approval, are still required to submit the project (deadline extended for 1 week).

b) Midterm 1

- Students may use an Academic Consideration request
- OR they can provide documentation to academic counselling
- For those using an Academic Consideration request, or with counseling approval, the weight of the midterm (15%) will be moved to the final exam.

c) Midterm 2

- Students may NOT use an Academic Consideration request
- Students must provide documentation to academic counselling
- For those with counseling approval, the weight of the midterm (30%) will be moved to the final exam.

Evaluation Scheme for Missed Assessments

There will be no make-up exams for a missed midterm. For those who do legitimately miss a

midterm and provide the required supporting documentation, the standard practice will be that the

weight of the missed midterm will be reassigned to the final exam. If your reason is not deemed valid, then you will receive a mark of 0.

If you miss the Final Exam and your Academic Consideration has been granted, you will be allowed to write the Special Examination (the name given by the University to a makeup Final Exam). See the Academic Calendar for details (under [Special Examinations](#)), especially for those who miss multiple final exams within one examination period.
