Honours Specialization in Actuarial Science

If you graduate from Western with an HSP in Actuarial Science, this course will be one of the courses that you will take in your program that will allow you to be exempt from the preliminary exams of the Society of Actuaries (SOA). If your plan is to become a fully qualified actuary working in Canada, then all you would need to do is graduate from your HSP in actuarial science and you would then be eligible for the CIA Capstone Exam. Taking and passing this exam, along with completing two online modules and a practice education course, would make you eligible to become an ACIA (Associate of the Canadian Institute of Actuaries).

#### Major in Actuarial Science

If you graduate from Western with a major in Actuarial Science, the CIA accreditation program will not apply to you. If your plan is to become a fully qualified actuary, then you will need to continue to write and pass the preliminary exams of the SOA.

## 5. Methods of Evaluation

The overall course grade will be calculated as listed below:

Both midterm exams will be in-class and scheduled for 2-hours. The midterms can include a combination of MC, TF, short-answer and in-depth problem-solving questions. Each midterm is incremental in its coverage of content, i.e., Midterm 2 covers the material after Midterm 1.

The Final Exam is scheduled by the Registrar's Office and will be for 2 hours. The exam is cumulative, and its questions could include short answer (1-2 paragraphs response), short essay (3-5 paragraphs), and in-depth problem solving, i.e., mathematical questions requiring several steps, commentary on your methodology and an interpretation of the conclusion relative to the question's initial context.

You must pass the final exam to pass the course. A failing grade in the final exam will be calculated as a final course grade of 45%.

### **Rounding of marks statement**

Across the Sciences Undergraduate Education programs, we strive to maintain high standards that reflect the effort that both students and faculty put into the teaching and learning experience during this course. All students will be treated equally and evaluated based only on their actual achievement

*Final grades* on this course, irrespective of the number of decimal places used in marking individual assignments and tests, will be calculated to one decimal place and rounded to the nearest integer, e.g., 74.4 becomes 74, and 74.5 becomes 75. Marks WILL NOT be bumped to the next grade or GPA, e.g. a 79 will NOT be bumped up to an 80, an 84 WILL NOT be bumped up to an 85, etc. The mark attained is the mark you achieved, and the mark assigned; requests for mark "bumping" will be denied.

## 6. Student Absences

If Midterm 1 is missed, its weight will be shifted to the Final Exam. Midterm 1 can be missed without formal documentation from Academic Counselling. In contrast, Midterm 2 requires formal Academic Counselling approval for any absence. If Midterm 2 alone is missed, its weight will be shifted to the Final Exam. If both Midterm 1 and Midterm 2 are missed, a special joint make-up midterm (in lieu of both Midterms 1 and 2) will be offered. The format and length of this make-up midterm may differ from the original.

The Final Exam always requires formal approval for any absences. If the Final Exam is missed, and if relief is granted, a make-up exam will be offered. The format and length of the make-up exam may vary from the original final exam. If this make-up exam is missed, and only with approval the exam can be written when the course is offered next.
