## S.97-26 London Free Press - Coverage of Western

He observed that in recent articles, references to the University's accomplishments have been either understated or negative. Mr. Garrard advised that he and the President have met with the *London Free Press* editorial board and reporters for the purpose of preserving a positive relationship between the press and the University; these efforts will continue. He advised that he will contact the *London Free Press* to ask why the recent stories were positioned as they were and report back to Senate.

# S.97-28b *Conditions of Appointment:* Alternative Procedures, Faculty of Health Sciences

Whereas the Faculty of Health Sciences will be a non-departmentalized Faculty with discipline-based Schools, with respect to *Conditions of Appointment*, in recognition of the Faculty's unique structure:

- 2. That the Faculty operate as a non-departmentalized Faculty, with the following alternative procedures:
  - a. That the Faculty Appointments Committee's composition and procedure be structured as set out in Exhibit I, Appendix 2.
  - b. That the Faculty Promotion and Tenure Committee's composition and procedure be as set out in Exhibit I, Appendix 3.

and

That, by February 1, 2000, the Provost initiate a review of these alternative procedures to determine whether they should be established through formal amendment to *Conditions of Appointment*. Any amendments to *Conditions of Appointment* would follow the usual procedures.

## S.97-38 **Bachelor of Health Sciences Program**

It was moved by B. Timney, seconded by G. Moran,

That the Faculty of Health Sciences introduce a general three-year or four-year Bachelor of Health Sciences program, as outlined in Exhibit III, Appendix 1, effective September 1, 1997.

Dr. T. Lennon, Acting Dean of the Faculty of Health Sciences, provided Senate with background on the development of the Bachelor of Health Sciences program detailed in Exhibit III, Appendix 1. He stated that the Bachelor of Health Sciences Committee established to formulate the program comprised two members from each of the three merging Faculties, one of whom was a member of the Joint Transition Committee, two members each from the Faculties of Science and Medicine and one member each from the Faculties of Social Science and Dentistry, with the Acting Dean of Health Sciences serving as Chair of the Committee. A model program was developed and refined following wide consultation with Deans, Department Chairs, and the Affiliated Colleges. He noted that the majority of responses received endorsed the program as a good program.

Dean Lennon addressed concerns raised during the program's consultative process:

- Now is the time to establish the program because it coincides with the beginning of a new Faculty.
- An enormous number of person hours were poured into the development of the program which commenced over five years ago at the initiation of Dr. Ralph Brooke.
- The logic and curricular integrity of the program is a judgment call by the Joint Transition Committee. Specifically, in the Committee's judgment, the program reflects a premise set out by SCUP as being at the basis, not only of the new program, but of the amalgamation of the new Faculty itself.
- The counselling of students is a priority given the complexity and multiplicity of offerings in the program. The BHSc Committee recommends that an academic counsellor be dedicated to this program alone. Additional counselling must be given to students enrolled in the Faculty of Science.

## **Comments on the Motion**

Dean Kang, on behalf of the Faculty of Science, spoke in support of the new program because it offers a unique opportunity for changing Western's image; the program represents a new initiative that will help improve Western's overall attractiveness. A strong BHSc program must be offered to attract the best qualified students. He added that certain concerns must be addressed, including the fact that the program is not an honors program which could present difficulties for students who wish to attend a professional school or transfer into honors programs. He emphasized the need for strong academic counselling for students enrolled in the BHSc.

Professor Seligman spoke against approval of the program in its current stage of development, stating that basic questions about the program have not been answered satisfactorily. He charged that the program has not been thought through and that more time is needed to address the program's inadequacies: the coherence of the program is not explained, nor is it explained whether the new courses in Health Sciences are intended to integrate the diverse course contents and methods that the students are exposed to in the program or what material specifically the new courses will cover. Professor Seligman stated that Western owes its students the assurance that when they graduate they can formulate and answer questions based on the systematic knowledge acquired in a degree program.

Professor Cheesman and Mr. Armstrong voiced concern that the program did not prepare students for entry into professional programs such as Occupational Therapy, Communicative Disorders, and Physical Therapy. As the program is structured, students will have an opportunity to explore these areas only in the final year, which is late and is not of a form to allow students to select options at other universities should they not be admitted into one of Western's professional health programs.

It was moved by K. Hilborn, seconded by R. Bryan,

That the motion be referred to SCAPA for appropriate consultation and reconsideration in light of the concerns raised at Senate.

#### Comments in favor of the Motion to Refer:

- Four new health sciences courses are proposed but no outlines are provided except for the first year course.
- The Senate debate imparts a general belief that the program requires more than just fine tuning.

## **Comments opposing the Motion to Refer:**

- The proposal was discussed at some length by the BHSc Committee and the Joint Transition Committee. The BHSc Committee, following wide consultation, considered and incorporated suggestions received.
- The Committee believes the program in its current form is strong as a general program but acknowledges that the program will need to be modified and fine-tuned as time progresses.
- The program is accepted as being good by Western's professional schools that were consulted during the development of the program.
- Proper academic counselling of students in the BHSc program will aid students in identifying career goals and the subsequent course selections needed for entrance into one of Western's professional schools.
- Referral of the program to SCAPA would not solve concerns about details, such as course titles. The principles on which the proposal is founded are acceptable.
- The program must be approved now if it is to be advertised to next year's potential students; to delay advertising the program by a month would be detrimental to the success of the program.
- SCAPA is prepared to consider adjustments to the program after the program has been approved by Senate.

Dean Lennon assured Senate that while the program will be housed in and administered by the new Faculty of Health Sciences, it is a University program that is largely dependent upon courses offered by other Faculties. The success of the program relies on the Educational Policy Committee and officers in the new Faculty who must oversee the program in a sensible and realistic way.

The motion to refer was called and was DEFEATED.

The main motion was called and CARRIED.

## S.97-39 Bachelor of Arts in Media, Information and Technoculture

It was moved by B. Timney, seconded by G. Moran,

That the Faculty of Communications and Open Learning introduce a three-year Bachelor of Arts program with an Area of Concentration in Media, Information and Technoculture (MIT), and a Combined Honors BA in Media, Information and Technoculture, as outlined in Exhibit III, Appendix 2, effective September 1, 1997.

## S.97-40 Faculty of Dentistry: Certificate of Qualification

It was moved by B. Timney, seconded by S. Graham,

That the Faculty of Dentistry establish a two-year qualifying program for graduates of non-accredited dental programs leading to a Certificate of Qualification, as outlined in Exhibit III, Appendix 3, effective August 1997.

## S.97-41 Faculty of Law: Revision to Admission Requirements

It was moved by B. Timney, seconded by W. Gibson,

That the minimum criteria for applying to Law School in the Regular category be revised from at least 70%, or an LSAT score above the 48th percentile, to an average of at least 75% or an LSAT score above 152, as shown below:

## CALENDAR COPY

**Regular Category** (S.91-12.1, S.92-40, S.92-115)

- At least two years of university level studies or of equivalent academic work are required. Candidates
  with only two years of university studies will be expected to achieve significantly higher results than
  those with more than two years. Candidates who are in their second year of study may be provisionally
  admitted.
- All candidates must have completed the LSAT. The Committee will use the LSAT score to choose the
  most eligible candidates and to eliminate the least competitive. The LSAT score will <u>not</u> be a factor in
  decisions concerning candidates outside these two groups. Normally, no applicant with an
  undergraduate average of less than 75% or an LSAT score below 152 will be considered for admission
  in the Regular category.
- Factors other than academic success will be considered in the case of candidates who have achieved more than the minimum standard of undergraduate grade average and LSAT score, but who are not automatically admitted on the basis of high undergraduate grade average and LSAT score.

These factors may include, but are not limited to, the overcoming of a proven disadvantage, and success in community affairs, politics, business, culture, the arts or athletics. Candidates must adequately document their claim for consideration. In no individual case will factors other than academic success be weighted more heavily than one third overall.

## S.97-48 Allocation of Seats on Senate

[Senate was given notice of the following motion on January 13, 1997 - S.97-22]

It was moved by J. Topolski, seconded by S. Martin,

That Senate direct the Operations/Agenda Committee to research the history of representation on Senate, take submissions from members of the University community with regards to future representation on Senate, and make a subsequent recommendation to Senate based on their findings no later than September of 1997.

Mr. Topolski, in support of his motion, provided the following rationale:

There is no available information regarding the composition of the Senate in regards to first principles, specifically addressing the numbers and ratios of voting seats.

- For example, why is it that the Faculty of Engineering Science has only 2 seats on Senate and the Faculty of Medicine has 5? Or why do Graduate representatives equal the combined amount of Social Science and Science representatives?
- Why does the LGIC have appointments on the Board of Governors but not the Senate?
- Why must the Faculty elect their [representatives] but the Alumni Association can appoint theirs?

It is the duty of Senate to address issues regarding possible overlaps or discrepancies in mandates of representatives.

Dr. Mercer, on behalf of the Joint Senate/Board Committee to Review the UWO Act, spoke against the motion. He noted that Mr. Topolski referred to the alleged obligation of the Joint Board/Senate Committee to Review the UWO Act to recommend changes to the Act. The Review Committee did not see that as their obligation, but did entertain comments about representation on Senate. Debate on Senate representation was public and broad and commentary on the issue was contained in the Review Committee's final report. Many of the issues raised by Mr. Topolski at this meeting have been addressed through the Review Committee's work and the most recent debate at Senate surrounding the proposal to apply for a variance in the number of elected faculty and student Senators. He asked if it would be possible to answer Mr. Topolski's questions in ways other than assigning a task that was recently done to the Operations/Agenda Committee.

Dean Mathur observed that legitimate questions are posed which should be answered such as why the Faculty of Graduate Studies has ten seats on Senate.

Mr. Topolski asserted that the UWO Act Review Committee did not adequately answer some of the questions, such as representation of Deans on Senate, during its review. He believed that the Operations/Agenda Committee could propose recommendations for future Senate compositions as a result of a new review.

It was moved by J. McKay, seconded by L. Weiner,

That consideration of the motion be postponed to the next meeting of Senate.

In support of his motion to postpone, Professor McKay proposed that Mr. Topolski's questions be answered and transmitted as required before the motion is considered by Senate.

Dr. Moran spoke against the motion to postpone and the main motion because the questions raised can be answered by any number of individuals on campus. He said that the issue of representation on Senate was debated at length at the January Senate meeting and the will of Senate was expressed through the mail vote following the January meeting given that 73% of the members of Senate voted in favor of the variance of the number of elected faculty and staff on Senate [see S.97-31b above].

Dean Mathur contended that it is logical to examine and respond to the questions raised because Senate will debate the redistribution of seats in the near future in the context of the merging of the Faculties of Medicine and Dentistry.

Mr. Topolski spoke against the motion to postpone because he believed other Senators might have additional questions and concerns. He said one purpose of his motion is to give Senate future directions concerning its composition.

The motion to postpone was called and was DEFEATED.

Mr. Topolski reiterated that it would be worthwhile for the betterment of Senate, and the University, to strike a committee to review the rationale and history of representation on Senate. Professor Hilborn questioned whether the proponents of the motion had actively sought answers to their questions from readily available sources, and in particular, the Senate Secretariat.

The main motion was called and was DEFEATED.
