Before considering the recommendation concerning the Specialization in Biomaterials, Senate accepted as a friendly amendment the inclusion of the following courses in the Module: "5.0 courses from: Calculus 250a/b or 280a/b, 251a/b or 281a/b, the former Applied Mathematics 290a, 291b".

It was moved by B. Timney, seconded by M. Wilson,

That a Specialization in Biomaterials, detailed in Exhibit III, item 2f (including the abovenoted addition), be introduced by the Faculty of Science, effective September 1, 2004.

#### S.04-208 Diploma and Certificate Programs in Organizational Development

It was moved by B. Timney, seconded by M.A. Andrusyszyn,

That a Diploma in Organizational Development and a Certificate in Organizational Development be introduced by the Faculty of Social Science in partnership with The Western Centre for Continuing Studies, effective September 1, 2005.

#### S.0-4-209 Breadth Requirement for Undergraduate Degrees

It was moved by B. Timney, seconded by M. Milde,

That the motion approved at the September 15, 2004, meeting of Senate, which read:

"That the policy statements on Breadth Requirements be revised to exclude courses in Writing"

be rescinded, and the following motion be introduced to replace it:

"That effective September 1, 2005,

- 1) Writing courses no longer be used to fulfill Breadth Requirements, i.e., count as Faculty of Arts courses for the three-faculty requirement,
- 2) students who successfully completed a Writing course prior to that date be permitted to use it to fulfill Breadth Requirements, and
- 3) policy statements on Breadth Requirements be revised to indicate this."

Professor Suarez asked that the Report on the Status of Reviews of Graduate Programs be revised to include the PhD program in Hispanic Studies in the list of proposals submitted to OCGS for Standard Appraisal found on page 19. Dean Kreiswirth agreed to revise the report accordingly.

## S.04-212 Payment of University-Administered Scholarships and Awards

SCAPA reported that the information in the second paragraph of the following policy is now incorrect and the paragraph will be deleted. It has been superceded by the policy on "Withdrawal or Reduced Course Load After Receiving University Administered Scholarships and Awards" which was approved by Senate in June 2004.

# PAYMENT OF UNIVERSITY-ADMINISTERED SCHOLARSHIPS AND AWARDS [S.89-55.01/.02]

Any UWO administered scholarship/award/prize will be automatically applied to the recipient's tuition account. Credit balances will be issued in the form of a cheque by October 31st and mailed to the sessional address.

Scholarship/award/prize recipients who withdraw after registration shall only be entitled to the value of the scholarship/award/prize as determined by the prorated cost of tuition calculated from the withdrawal date.

## S.04-213 <u>Reciprocal Articulation Agreement for Environmental Science Graduates of UWO or</u> <u>Fanshawe College</u>

At the October 15, 2004, meeting of Senate, a recommendation was approved that effective September 1, 2004, advanced standing be granted to UWO Environmental Science students who are graduates of Fanshawe College, and Fanshawe College students who are graduates of Environmental Science modules at UWO.

The agreed terms were shown in the Background of the Senate Agenda item; however, the information was incomplete. A full listing of the terms of the agreement, including the details on the Science Laboratory Technology Diploma which had not been included, is set out in Exhibit III, Appendix 2.

That Senate approve and recommend to the Board of Governors that the name of the Faculty of Arts be changed to "Faculty of Arts and Humanities", as recommended by the Council of the Faculty.

## S.04-215 Future Fundraising Objectives for Western

It was moved by G. Moran, seconded by M. Wilson,

That Senate approve and recommend to the Board of Governors, through the Vice-Chancellor,

That the following annual fundraising goals be set:

•	\$35,000,000	2004-05
•	\$46,250,000	2005-06
•	\$46,250,000	2006-07

and

that an additional \$30,000,000 be the fundraising target through the Planned Giving program (i.e., gifts from estates, life insurance, etc.).

Mr. Garrard provided an overview of the future fundraising objectives for Western detailed in Exhibit IV, Appendix 1.

Professor Carroll asked for clarification of the anomaly in the recommended goal associated with the Faculty of Science. Mr. Garrard stated that the experience in raising matching funds through the CFI program is such that very specific private sector partners donate to specific research projects. Professor Carroll asked what will happen should the donors not give the expected amount of money. Mr. Garrard explained that a "war chest" is set aside in the event that private sector funding cannot be secured.

The question was called and CARRIED.

#### S.04-216 Report on Applications, Confirmation Rates, Entering Averages and First-Year Grades

Dr. Moran presented the Report on Applications, Confirmation Rates, Entering Averages and First-Year Grades. Overhead slides used to highlight his presentation are attached as Appendix 2.

Senators engaged in a discussion about application procedures, grade inflation, and admission averages.

Professor Carroll asked why the first year grades in the Faculty of Arts are so much higher than those in the Faculty of Social Science and Science. He asked if this trend in grades for Arts students and Social Science students continues into the second and third years. He contended that the students in the Faculty of Social Science are at a disadvantage when competing for SSHRC-related scholarships because of lower grades. Dean Esterhammer agreed to investigate the situation to determine if Arts students have an advantage over Social Science students in competitions for SSHRC-related scholarships. Dr. Moran also asked the Chair of SCAPA to review this matter.

#### S.04-217 Planning for 2005-07: Guidelines for the Faculties

The Planning Guidelines for the Faculties for years 3 and 4 of the Four-Year Planning Process, detailed in Exhibit IV, Appendix 2, were received for information.

## S.04-218 Collaborative Research Entities

Senate received for information the revised listing of Collaborative Research Entities that were approved from 2003 to September 2004, detailed in Exhibit IV, Appendix 3.

Senate received for information Announcements and Communications detailed in Exhibit V.

#### **ENQUIRIES**

#### S.04-220 Academic Freedom at King's University College

Professor Carroll recalled that the *Gazette* recently published an article about the firing of a King's University College Residence Assistant for distributing condoms. The *Gazette* article quoted Dr. Killan, Principal of King's University College: "The condoms were being distributed in an indiscreet fashion. King's is guided by its Roman Catholic mission and must abide by it and ensure that none of its employees are misrepresenting it." In Professor Carroll's view, there is a link between Dr. Killan's reason for justifying the firing of the Residence Assistant and academic freedom. Faculty at King's are also their employees, students from Western attend classes at King's and Senate approves course proposals submitted by King's. Professor Carroll asked if faculty at King's have academic freedom, that is, can faculty pursue truth in the classroom without regard to authority, including the authority of the Catholic church, and without regard to the Roman Catholic mission of King's University College.

Dr. Killan corrected Professor Carroll by stating that the Residence Assistant was not fired for distributing condoms. He confirmed that faculty at King's do enjoy academic freedom: the King's University College *Terms and Conditions - Faculty* document contains the full CAUT definition of academic freedom.

## S.04-221 <u>Central Timetabling</u> [S.04-141, S.04-187]

Professor White thanked faculty for their feedback on the draft timetable and announced that pending a review of the second release of the draft timetable, he would raise concerns about the central timetabling issue at the December Senate meeting.


