- (c) 5 persons, one of whom shall be an undergraduate student enrolled in the Faculty or a graduate student enrolled in a program housed in the Faculty, elected by the Council of the Faculty concerned
- 3 persons elected by Senate, who are not faculty, staff or students of the Faculty (d) concerned, and only one of whom may be a Dean,
- for Medicine & Dentistry, one President of a London teaching hospital affiliated (e) with the University, named by the Hospital Presidents;

for Business, two members of the Ivey Advisory Board, named by the Advisory

UNIVERSITY PLANNING [Exhibit III]

S.06-16 <u>First-Year, First-Entry Undergraduate Enrolment for the Constituent University and Affiliated</u> University Colleges

It was moved by F. Longstaffe, seconded by C. Brown,

That Senate approve the following targets and processes for first-year, first-entry undergraduate enrolment for the Constituent University and Affiliated University Colleges:

- 1. For the Constituent University, the first-entry undergraduate enrolment target for each of 2006-07, 2007-08 and 2008-09 is 4,350 and the approximate program specific objectives for 2006-07 are as described in the attached Exhibit III, Appendix 1.
- 2. For the Affiliated University Colleges, the targets for 2006-07 are:

Brescia - 260 students Huron - 385 students King's - 790 students

- 3. The process for the Constituent University includes the following elements:
 - (a) The Provost is granted permission to alter the enrolment objective for 2006-07, following consultation and approval from SUEPP, as might be appropriate given the particulars of a government funding announcement.
 - (b) Entrance requirements will be set by the Provost to achieve the enrolment objective for 2006-07 as a function of final admission numbers, qualifications of applicants, and estimates of the rate of offer confirmations in each program.
 - (c) No program-specific entrance requirement will be set below an A average in 2006-07 except where performance is a major element of the selection process. Although the exact value will ultimately be determined by this initial admission minimum, confirmed admission to any program will be contingent on a final average grade of no lower than 77%, except in those programs involving performance criteria and in particular limited enrolment programs where the value may be higher.
 - (d) The enrolment projections (Exhibit III, Appendix 2) will be used for purposes of tuition revenue estimates in the 2006-07 University's budget projections.
- 4. The process for the Affiliated University Colleges includes the following elements for 2006-07:
 - (a) General entrance requirements will not be set until more complete information on applicant qualifications is available.
 - (b) Offers will be extended to current Ontario high school students using the same process as described for the Constituent University.
 - (c) Each College will determine its own timelines for extending offers of admission and response dates.
 - (d) No student will be admitted to first-year study directly from the Ontario secondary school system with final grades below 75%, unless detailed academic assessment deems this appropriate.
 - (e) All Affiliated Colleges will be bound to the minimum entrance requirements established by the Constituent University for limited enrolment programs, where applicable, including Media, Information & Technoculture, BHSc, and Kinesiology.

Senate also received Implementation Notes for 2006-07 for the Constituent University as follows:

- 1. Given the experience of recent years, it is virtually certain that minimum entrance requirements will continue to be above 80%.
- 2. Students made offers by Ontario universities traditionally have been required to accept their offer by mid-June and pay various deposits (tuition, residence, etc) or lose their place. Beginning in 2003-04, the Council of Ontario Universities agreed to allow universities to

request a response to an offer of admission, without any financial commitment, by mid-May. Recognizing that not all institutions would have all offers out in April, COU also retained the traditional mid-June (for 2006-07 the actual date is June 12, 2006) response date which may then include a financial commitment from the students.

As a result of the earlier response date, the timing of the application and offers process for current Ontario secondary school students will begin with offers of admission in January on a rolling basis to exceptional students, made largely on the basis of performance prior to Grade 12.

The subsequent rounds of offers will begin in March/April as soon as the initial Grade 12 marks are available. Specific minimum grades required for an offer will be set as a function of final information regarding applicant qualifications in each program.

Marks used for early offers in April 2006 will be determined by the size and quality of the applicant pool.

- 3. Every effort will be made to maintain a single minimum standard of admission across all programs. However, a higher standard may be necessary in some programs such as Nursing, Media, Information & Technoculture, and Media, Theory & Production to avoid exceeding program capacity.
- 4. As indicated in the Senate resolution of Spring of past years, consideration may be given in the admissions process to factors such as performance in program-relevant courses (e.g., mathematics and sciences in Science and Engineering), and the academic record of the secondary school. As well, consideration will be given to students based on special circumstances and extraordinary extracurricular activities and/or contributions to citizenship.
- 5. As was the case in past years, the period between the availability of initial application information (still not including final year, winter semester applicant grades) and the offer date, does not permit an admissions proposal that includes detailed program-specific admissions criteria to be brought to Senate for consideration before initial offers were made.
- 6. A final round of offers, based on complete grade information, will be made in May 2006. Criteria used for those offers will be set as a function of additional information on applicant qualifications, historical program-specific patterns of acceptance of early offers, and student responses to date, but will observe the general entrance requirements established in this recommendation.

Professor Carroll asked why the enrolment at the King's University College, both actual and projected, seems to increase dramatically. Dr. Killan explained that the projected numbers were based on a specific target, determined in discussions between King's and Western, and that actual enrolments are likely to be somewhat lower. He indicated that the projected numbers include international students.

Professor Carroll asked for the rationale behind the enrolment increase in the Executive MBA program. Actual enrolment is 178 and the 2006-07 projected enrolment is 236. Professor Robertson stated that a strong marketing campaign, a change in the location of the program and the change to a continental program format (four days per month, Thursday through Sunday) accounts for the anticipated increase in enrolment.

Referring to Exhibit III, Appendix 2, line 17, Ms. Zener asked for clarification regarding the enrolment increase in the MD program over the next five years. Professor Doerksen took the

question under advisement. Dr. Davenport suggested that the increase could be related to the School's plans for expansion of medical programs through a collaboration with the University of Windsor.

Professor Toswell asked for an explanation of the enrolment fluctuations associated with the "BMedSci" program. Dr. Harris explained that enrolment in this program over the last few years has grown substantially. Discussions are ongoing with the Faculty of Science and the Schulich School of Medicine & Dentistry to determine a reasonable number of students who can be accommodated in the upper years of the program.

The question was called and CARRIED.

S.06-17 <u>Vice-Provost's Report on Faculty Recruitment</u>

The Vice-Provost (Academic Policy, Planning & Faculty) gave his regular report on Faculty Recruitment based on slides provided in Exhibit III, Appendices 2 and 3. New data in this report included information about the comparative presence of probationary and tenured women faculty by Faculty and School. Dr. Weedon agreed with a suggestion that it might be helpful to have the data further refined to provide information about numbers of women faculty in departments. He would explore this possibility for future reports.

S.06-18 **REPORT OF THE ACADEMIC COLLEAGUE**

The Report of the Academic Colleague on the 278th meeting of the Council of Ontario Universities, detailed in Exhibit IV, was received for information. Topics discussed included: undergraduate degree standards; preparations for graduate enrolment expansion; and changes in student learning behaviour.
