### **BUSINESS ARISING FROM THE MINUTES**

# S.07-186 **Agency of Record**

In Mr. Garrard's absence, Dr. Davenport responded to questions previously raised by Senators about Western's Agency of Record, The Marketing Department. The Marketing Department will support external communications, branding and marketing efforts by providing strategic advice on how Western can best promote its mission, will develop creative concepts for our external advertising and promotional materials, will design promotional materials such as recruitment publications, alumni and fundraising publications and will ensure consistency in how the University visually represents itself. There is value in having an Agency of Record to help coordinate Western's external communications and advertising and he encouraged Faculties and Department to use its services, but stressed that no one is compelled to so do. Dr. Davenport asked that Senators contact Mr. Garrard with any further questions about this matter.

#### S.07-187 **REPORT OF THE PRESIDENT**

Dr. Davenport reported on the Globe & Mail University Report Card 2007 and Faculty and Staff Award Nominations. Overhead slides used to highlight his presentation are attached as **Appendix 1**.

In Vice-President Hewitt's absence he provided an update on discussions at the University Research Board (URB) with respect to military-related research. This issue first came to Senate's attention in December 2004 as a result of a research contract between the Faculty of Engineering and General Dynamics. Dr. Davenport acknowledged that faculty at Western are involved in a great deal of research that one could deem controversial but Western's pledge to its faculty is that as long as the research falls within Western's research guidelines and the laws of Canada and Ontario, they are free to do whatever research they want. This is a cornerstone of academic freedom. Those who disagree with a particular research project or finding are equally free to criticize it or the faculty member involved. Western does not as an institution stop research because one party or another deems it controversial.

Professor Dyer-Witheford had made a presentation on the issue of military research to the University Research Board (URB) on May 8, 2007 and as a result of that presentation asked Dr. Hewitt to raise this issue with his colleagues at the Ontario Council of University Research and at a meeting of the G13 Vice-Presidents (Research). Dr. Hewitt has met with the Ontario Council on University Research. The meeting of the G13 Vice-Presidents Research is today. Consequently, Dr. Hewitt will be reporting on this matter to the URB at its next meeting and subsequently to Senate.

#### S.07-205 Timing of Hong Kong Convocation Ceremonies

Senate was advised that the policy on eligibility for participating in the Spring Hong Kong Convocation ceremony, contained in the Academic Handbook, will be revised as follows to reflect the change in timing from the October/November time frame to March/April and to add a reference to the February granting of an "in absentia" degree.

### <u>Policy on Eligibility for Participating in the Spring Hong Kong Convocation</u> Ceremonies

There will be a University-wide Convocation Ceremony in Hong Kong that involves, in addition to those who complete their Executive MBA degree in Hong Kong, any undergraduate or graduate student who was eligible to graduate at the Spring or Fall or Convocation ceremonies of the preceding year in London or at the February in absentia degree conferral of the same year. Students are required to apply to participate in the Hong Kong ceremony and will receive either their degree diploma (if not collected at a London ceremony) or a Certificate of Participation.

## S.07-206 Structure of the Academic Year: Projected Dates

The Guidelines for the Structure of the Academic Year allow the University to project dates for the start and end of terms, study days and examination periods, convocation ceremonies, etc. The dates shown in Exhibit III, item 9 for 2008-09 to 2015-16 have been modified slightly in some cases from the dates currently posted on the web in order to take into account: revised dates for first term to begin on a Monday in 2010 and 2013 (because Rosh Hashanah falls on a Thursday); a recent request by the President of the University Students' Council to have two study days whenever possible within the parameters of the policy. The policy statement has been revised to include a reference to the timing of the *In Absentia* Convocation approved by Senate in 2006, and is contingent on approval of the timing of the convocation ceremonies, covered in item 3 above.

Professor Milde noted that the projected dates would not be finalized until decisions were made with respect to accommodation in the academic calendar of the new public holiday (Family Day) recently announced by the provincial government.
