# S.08-201 By-Law Amendment - Speakers at Senate

It was moved by T. Carmichael, seconded by R. Stainton,

That By-Law Number IV.6 be amended to read as follows:

Normally, only Senators or official Senate Observers may speak at Senate. However, the Operations/Agenda Committee or the Chair of Senate or the person authorized to act in that capacity may invite to Senate meetings special guests, or other persons who they think could contribute to debate or discussion on any Senate matter to be discussed at a meeting to serve as a resource or to provide information on any Senate matter. In exceptional circumstances, Senate may also, by a two-thirds majority vote, elect to permit a guest to be heard at Senate.

Asked who would determine when the circumstances are exceptional and why a two-thirds majority vote is needed rather than a simple majority, Dean Carmichael said that it would be Senate's determination that the circumstances were exceptional. Requiring a two-thirds majority vote shows that the request to permit a speaker has broad support from Senators. Professor Stainton reported that the Operations/Agenda Committee discussed this point and concluded that a two-thirds majority vote was appropriate given the procedural nature of the proposal. Many procedural motions require a two-thirds majority.

It was moved by A. Chant, seconded by R. Coulter,

That the phrases "In exceptional circumstances" and "by two-thirds majority vote" be deleted from the recommendation.

Speaking in support of the amendment, Mr. Chant stated that the phrase "in exceptional circumstances" could be cumbersome and that a simple majority vote is more acceptable. Professor Coulter remarked that Senate's work is public and transparent and that a simple majority of Senators should be trusted to be able to make a decision; requiring a two-thirds majority is an unusual requirement normally reserved for constitutional and by-law changes.

Professor Baerg reiterated that the Operations/Agenda Committee discussed these two issues and agreed that Senators elected or appointed can speak at any time in Senate on any issue. Allowing non-Senators to speak at Senate is exceptional which is why a two-thirds majority vote is appropriate.

It was moved by A. Chant, seconded by A. Thom,

That the motion to amend be split.

CARRIED

The Chair asked for discussion first on the proposal to delete "in exceptional circumstances" from the main motion.

Addressing concerns regarding the inclusion of the phrase "exceptional circumstances", Dean Carmichael stated that Senators are elected by their constituency to speak on its behalf. The by-laws state that Senators are not allowed to bring proxies or let others speak for them. It is incumbent upon Senators to educate themselves about issues presented at Senate. In exceptional circumstances, however, Senate can determine that a non-Senator should be allowed to address Senate in a resource capacity. Professor Coulter remarked that inclusion of the phrase limits the power of Senate regardless of whether the circumstances are exceptional or not.

The amendment was called and DEFEATED.

The Chair called for discussion on the deletion of the phrase "by a two-thirds majority vote" from the main motion.

Asked how frequently guests would speak at Senate, Dr. Davenport said that about once or twice a year a non-Senator addresses Senate in a resource capacity following approval by the Operations/Agenda Committee.

Mr. Telfer said that it is important that Senate have procedures in place to deal with such issues but he believed that the proposed language would limit Senate's ability to decide from whom it wishes to hear.

Dean Carmichael said that the requirement of a two-thirds majority vote would signal wide-spread support for the resource information that could be supplied.

The amendment was called and DEFEATED.

The main motion was called and CARRIED.

# S.08-202 Appointment Procedures for Senior Academic and Administrative Officers of the University:

S.08-202a Amendment to Section M. - Deans of Faculties

It was moved by T. Carmichael, seconded by T. Baerg,

That Section M.(e) of the Appointment Procedures for Senior Academic and Administrative Officers of the University be amended as follows:

M. DEANS OF FACULTIES

Composition of Selection Committee

A committee to select a Dean of a Faculty shall consist of:

- (a) the Provost & Vice-President (Academic), who shall be Chair
- (b) the Vice-President (Research & International Relations)
- (c) 5 persons, one of whom shall be an undergraduate student enrolled in the Faculty or a graduate student enrolled in a program housed in the relevant Faculty, elected by the Council of the Faculty concerned
- (d) 3 persons elected by Senate, who are not faculty, staff or students of the Faculty concerned, and only one of whom may be a Dean,
- (e) for Medicine & Dentistry, the President and Chief Executive Officer of the London Health Sciences Centre/St. Joseph's Health Care or designate, and one Robarts Scientist identified by the Robarts Scientists, and one additional student and faculty member elected by the Council of the Schulich School of Medicine & Dentistry
  - for Engineering, one member of the Advisory Council of Western Engineering, named by the Advisory Council;
  - for Business, two members of the Ivey Advisory Board, named by the Advisory Board;
  - for Law, one member of the Law Alumni Association, named by the Association.

# S.08-202b Amendment to Section P - University Librarian

It was moved by T. Carmichael, seconded by T. Baerg,

That Section P - University Librarian, of the Appointment Procedures for Senior Academic and Administrative Officers of the University be amended as follows:

# P. UNIVERSITY LIBRARIAN

Composition of Selection Committee

A committee to select a University Librarian/*conduct a five-year review of the Library* shall consist of:

- (a) the Provost & Vice-President (Academic), who shall be Chair
- (b) the Vice-President (Research & International Relations)
- (c) the Vice-Provost (Graduate & Postdoctoral Studies)
- (d) 2 3 members of the full-time library staff, one of whom must be a

- professional librarian or archivist, elected by the full-time library staff
- (e) **2 3** members of faculty and 1 student, elected by Senate

That the terms of reference of the Subcommittee on Undergraduate Program Review, shown in Exhibit I, item 5A, be revised to clarify that the reviewers' report to SUUPR will consist of:

- 1) the report of the external reviewer(s), including the making of recommendations, and the response to the report by the Chair and/or Dean, to be submitted in confidence for discussion by SUUPR.
- 2) a summary of the review of the program, prepared by an internal reviewer for the Constituent University and by the Academic Dean or designate for an Affiliated University College, which will be included in the annual report to SCAPA and Senate subject to minor revisions which may be made by SUUPR as a result of its review.

That the Guidelines on the Structure of the Academic Year be revised (including the correction noted above) by adding the last day of registration for Fall and Winter sessions as detailed in Exhibit III, item 6.

#### S.08-220 Annual Report on Scholastic Offences

Included in the regulations on Scholastic Discipline (S.03-77a) approved by Senate on April 11, 2003, is the requirement that:

"Each Faculty shall submit to the Vice-Provost & Registrar an annual summary of scholastic offences committed by students registered in the Faculty. The summary will set out the nature of the offence and the penalties, with students' names removed. The Vice-Provost &

Registrar will compile the information, by Faculty, and report annually to the Senate Committee on Academic Policy and Awards which will forward the report to Senate for information."

The 2007-2008 Report on Scholastic Offences, covering the period from July 1, 2007 to June 30, 2008, detailed in Exhibit III, Appendix 3, was received for information.

#### S.08-221 MBA'80 Professorship in Entrepreneurship

It was moved by C. Dunbar, seconded by J. Berge,

That Senate approve and recommend to the Board of Governors, that the MBA'80 Professorship in Entrepreneurship be established at the Richard Ivey School of Business, for a five-year period based on an expendable gift, under the terms of reference shown in Exhibit IV, item 1.

## S.08-222 Update on University Operating Budget

Dr. Longstaffe provided an update on the University operating budget including a review of the 2008-09 budget, reserves at year-end 2007-08, downturn in Equity Markets, downturn in equity markets and Western's endowments, impact of the downturn on the operating budget in the current year, dealing with longer-term constraints in the operating budget, looking beyond the current four-year plan, and aspirations with graduate expansion. Overhead slides used to highlight his presentation are attached as **Appendix 2**.

Asked about the impact the financial situation could have on student financial aid, Dr. Longstaffe said the administration is cautiously hopeful that the current market situation will not have a negative impact on student financial aid; however, the situation remains uncertain until February 2009. Planned payouts of endowed funds used to support student scholarships and bursaries have been made for 2008-09 and are not affected by the market turmoil.

A Senator asked if the province might put pressure on universities to increase undergraduate enrolment. Dr. Longstaffe replied that Western has spent considerable effort in achieving the right balance of undergraduate and graduate students but acknowledged that the province continues to be concerned about access to post secondary education. An increase in undergraduate enrolment would provide additional revenue, however, it would not be a wise investment given the possible negative impact on providing the best educational experience. Dr. Davenport assured Senate that he will continue to urge the Premier to "stay the course" regarding graduate growth.

Asked about the impact the financial situation will have on staffing, Dr. Longstaffe said that controlling expenditures will aid in protecting staff, but the initial budget reduction will create staffing challenges as to whether units can replace or hire faculty and staff.

Responding to a question as to what percentage of faculty budgets is committed to salaries, Dr. Longstaffe said he could not provide an exact figure but agreed to bring this information back to the next Senate meeting.

Dr. Davenport noted that he and Dr. Longstaffe would be updating Senate regularly on the financial situation but reminded Senators that the Board of Governors has the final say on budget matters.
