S.15-01 **MINUTES OF THE PREVIOUS MEETING**

The minutes of the meeting of December 5, 2014 were approved with the inclusion of the following correction to the second sentence in S.14-230: Western's Financial Matters:

...100% of the funding for Research Masters and PhDs will be available for graduate support through the Faculties and SGPS.

S.15-02 **REPORT OF THE PRESIDENT**

The President reported on the following items: Visit of the Premier to three universities, including Western, Provincial budget discussion, recent appointment of Dr. Robert Andersen as the new Dean of the Faculty of Social Science, and Professor Jeremy McNeill named a Member of the Order of Canada.

Ms. Kulczycki provided an update on the Campus Master Plan noting that communications will be forthcoming soon to direct campus community members to a website where more information on the plan will be available and also allow for feedback to the planning committee. She advised that it is expected that the revised campus master plan document will be presented for approval to Senate in April.

Dr. Hearn, President of UWOFA, noted that as part of the Premier's visit she met with members of UWOFA's leadership team during which time they discussed the rising use of short-term contract faculty and the impact on academic freedom.

S.15-06 **Notice of Motion re Appointment Procedures for Senior Academic & Administrative Officers of the University**

At the December meeting of Senate, Senator J. Toswell submitted a notice of motion concerning an amendment to the *Appointment Procedures for Senior Academic & Administrative Officers of the University* that would add to the Appointment Procedures the process for selecting an Associate Vice-President (Student Experience). The motion included the details of the composition of a selection committee. As the amendment of the Appointment Procedures requires the approval of both the Senate and the Board, the notice of motion is clearly in order to be placed on the Senate agenda. However, with the consent of Senator Toswell, it has been determined that it would be better to defer discussion of the motion until the April meeting of Senate. That will give the Provost time to complete the current search and to reflect upon whether, in light of that experience, the proposed composition of the selection committee going forward is optimal or whether a different composition should be proposed.

Summer Co-op in Economics

Background

The Economics Summer Co-op Program was introduced in 2006 to provide Economics students with work experience related to their studies. The optional program was available to all full-time undergraduate students on campus, after they finished Year 3 and continued in Year 4 in the Honors Specialization in Economics or in a Double Major with one of the Majors in Economics. The program had no students registering in it, therefore it is withdrawn. The Economics 4499 – Economics Summer Co-op - course was withdrawn in a separate DAP proposal in the fall of 2014.

2. School of Graduate and Postdoctoral Studies: Dual-Credential Ph.D Degree Agreement between the Université Libre de Bruxelles (Belgium) and The University of Western Ontario

Recommended: That effective January 1, the introduction of a Dual-Credential Ph.D Degree Agreement between The Université Libre de Bruxelles (Belgium) and The University of Western Ontario be approved as shown in **Appendix 1**.

Background:

The proposed program's details (attached as [Appendix 1](#)) were developed by the School of Graduate and Postdoctoral Studies, with involvement from the Office of the Vice-Provost (International).

3. **Schulich School of Medicine & Dentistry and Faculty of Science: Revision of the Combined BSc (Interdisciplinary Medical Sciences)/HBA Program**

Recommended: That the Year 4 BSc requirements for the Combined BSc (Interdisciplinary Medical Sciences)/HBA Program be revised effective September 1, 2015, as shown in [Appendix 2](#).

Background:

When the Combined BSc/HBA program that includes the Honors Specialization in Interdisciplinary Medical Sciences (IMS) was introduced, only 9.0 of the 10.0 courses in the Honors Specialization in IMS were required in the combined program. Since that time, and following much discussion, a Combined BSc (Biochemistry)/HBA Program has been introduced. During the discussion phase, the various basic medical science departments agreed that any new Combined BSc/HBA programs should require the same number of courses for the Honors Specialization module as in a "regular" BSc degree. It was agreed upon that the BSc portion of the existing Combined BSc (Interdisciplinary Medical Sciences)/HBA Program be expanded to only to courses (rather than 10.0 courses of the Honors Specialization in IMS). The expansion will be accomplished by adding a course from Group 3 so that students will satisfy the prerequisite for Medical Sciences 4900F/G which is being revised to include a course from Group 3 for September 2015. Students will register in the Combined BSc (Interdisciplinary Medical Sciences)/HBA Program for the first time in September 2015 and adding this half course from Group 3 for this group of students will bring their course selection in-line with students in a BSc degree with an Honors Specialization in IMS. Additional revisions to the module include re-naming the Groups from A, B and C to 1, 2 and 3 to reduce confusion with breadth requirements (Categories A, B and C), and the addition/removal of basic medical science courses since the last update. References to "September 2013" are being also removed as they are no longer necessary.

4. **Brescia University College: Introduction of the Specialization and Honors Specialization in Nonprofit Management (BMOS)**

Recommended: That effective September 1, 2015, the Specialization and Honors Specialization in Nonprofit Management leading to a BMOS degree be introduced at Brescia University College contingent upon the Quality Council's approval as shown in [Appendix 3](#)

Background

The combination of Brescia's strong history of commitment to community service-learning, student interest in the field, the predominantly female nature of the nonprofit sector and demand from our community partners to better prepare students for challenges in this sector have prompted Brescia to develop this new module.

Brescia has successfully launched a MOS program that builds on existing institutional strengths in its Food Management modules (major, specialization, honors specialization). The development of the Nonprofit Management modules is another example of Brescia's commitment to build on its core competencies.

Nonprofit Management is an interdisciplinary module comprised of MOS and social sciences courses, primarily Community Development (Sociology) and Dimensions of Leadership that will prepare students to make valuable contributions to nonprofit organizations such as community organizations and social enterprises. The unique combination of MOS and social sciences courses in these modules support the vision of the MOS degree and add value to the MOS brand at Western.

The new modules were considered as new programs by SUPR-U in September 2014 and they went through the external review process in November 2014. The Final Assessment Form of the external review is appended as [Appendix 4](#).

5. **Brescia University College, Department of Sociology: Renaming and Revising the Honors Specialization in Crime and Communities, Major in the Sociology of Law, Crime and Deviance and Minor in Criminology**

Recommended: That effective September 1, 2015, the modules

- Honors Specialization in Crime and Communities
- Major in Sociology of Law, Crime and Deviance
- Minor in Criminology

be renamed and revised as shown in **Appendix 5**, and

That students currently enrolled in these modules be allowed to graduate with the old designation by September 1, 2017.

Background:

The module title, Major in the Sociology of Law, Crime and Deviance, while capturing the types of course offerings in the module, is amorphous and not in-line with recognized university program names. The renaming the module to Major in Criminal Justice acknowledges the specificity of its focus. The modules will be aligned in name and course requirements by renaming and revising their content. The new course requirements will emphasize the focus on criminal justice, which is the main area of interest of faculty members in the Department of Sociology at Brescia.

Students are now able apply to graduate via the Student Centre on-line at any time, therefore there is no need to accommodate weekends or holidays for this process.

The policies and regulations of the Senate and the School of Graduate and Postdoctoral Studies.

The parties agree as follows:

PREAMBLE

The Université Libre de Bruxelles and Western agree to allow students to perform coordinated doctoral studies in French Studies at both Institutions by spending periods of similar duration at both sites, jointly guided by scientific supervisors from both Institutions, aimed at obtaining the doctoral title from each Institution by satisfying the requirements and quality standards of the doctoral studies of each Institution. The purpose of this Agreement is to set out the rules, rights, and obligations of the parties with respect to the conduct of the coordinated doctoral studies program.

The partner institutions give their consent to the preparation of the doctoral thesis which will be carried out and defended under the partner institutions' responsibilities as outlined below.

SECTION 1 : THE DOCTORAL CANDIDATE

Article 1.

This Agreement is organized for the benefit of the following doctoral candidate:

Article 2.

The doctoral candidate is bound by the regulations in force within each institution.

SECTION 2: ENROLMENT IN THE PHD

Article 3.

The doctoral candidate is registered:

2. At the University of Western (home institution)

For a PhD in - **Doctor of Philosophy ("PhD")**

And for the PhD beginning in the academic year:

Article 4. Funding

Throughout the Dual Ph.D. program, the student will be enrolled at both institutions. However, students will pay fees and tuition only to Western (home institution), even while resident at the host university which is the Université Libre de Bruxelles. When registering for the first time, the doctoral candidate will pay the registration fees at the Université Libre de Bruxelles. The years after, only enrolment fees and administration costs will be paid by the doctoral candidate to the Université Libre de Bruxelles. No additional fees will be required by the Université Libre de Bruxelles in the framework of the present Agreement, with the exception of health insurance fees as described in section 6 of this Agreement. While a doctoral student in the course of meeting degree requirements stipulated by this agreement, the candidate will receive financial support as determined by Western. For students at Western, the maximum period of funding is normally twelve terms.

Article 5.

The dual degree program takes effect for the academic year **2012 - 2013**

Article 6. Insurance

Social security cover (in Belgium) for the doctoral student will be ensured under the following conditions.

The doctoral candidate is covered by Belgian social security insurance, in accordance with the relevant national legislation, upon condition they are registered at both institutions. The doctoral candidate will subscribe to a main insurance policy in Belgium.

Regarding the personal liability insurance:

- At the Université libre de Bruxelles: the doctoral candidate is covered for personal liability and physical injury upon condition they are registered at the University.
- At The University of Western Ontario: the doctoral candidate is covered under the University's general liability insurance while registered at the University. Western does not provide accident insurance to doctoral candidates. While at Western the doctoral candidates and any accompanying dependents must purchase coverage under the University Health Insurance Program (UHIP).

While they are at each Institution, students are required to comply with each Institution's health and workplace safety requirements.

SECTION 3 : PROGRAM REQUIREMENTS

Article 7.

In each institution, the doctoral candidates carry out their work under the supervision and the responsibility of a thesis supervisor who is a member of the graduate studies.

The supervisors undertake to act fully as supervisors to the doctoral candidate, and to ensure that this function is carried out within the conditions that apply in the respective institutions.

They will collaborate regularly over the progress of the doctoral candidate's research work.

Article 8.

At the Université libre de Bruxelles, a supervisory committee monitors the doctoral candidate while they are working on their thesis. It sets the content of the doctoral training, awards ECTS credits for activities carried out as part of the doctoral training and meets with the doctoral candidate at least once per year in order to assess progress. On the basis of this annual evaluation, the supervisory committee informs the relevant authority of their opinion regarding re-enrolment.

Prior to the thesis defence, at the Université libre de Bruxelles, the doctoral candidate must complete

the doctoral training programme (60 ECTS).

At Western, the candidate must complete the normal requirements of the program, which includes course work and the comprehensive exams, the thesis proposal, and thesis submission, prior to thesis defence.

Article 11. Duration of program

The normal duration of the research work is 12 terms (4 years), unless extraordinary and exceptional situations justify an extension. Extensions will only be granted upon agreement of both Institutions and they are subject to the regulations of the two Institutions.

The preparation of the doctoral thesis will be divided between the partner institutions, by alternate periods. To ensure the reality of joint supervision, each partner institution will supervise the doctoral candidate for at least one year.

Article 12.

The preparation of the doctoral thesis will be supervised by the partner institutions, according to the schedule below:

Course work and comprehensive exams at Western (2 years of study)

Study and research; public seminar of thesis at Université Libre de Bruxelles

SECTION 4: DEFENSE AND DIPLOMAS

Article 13.

The doctoral candidate will submit the thesis to both institutions upon completion of the requirements, as noted in article 10. Candidates must be enrolled in the doctoral program to submit the thesis.

Article 14.

The Thesis Examination Board (jury) will be composed by mutual agreement between the partner institutions, in conformity with the regulations of both institutions.

The Examination Board will be composed of two examiners (academics) from the Université Libre de Bruxelles, including the supervisor; two examiners from Western (not including the supervisor), and at least **one** external member to both universities, all of them PhD holders. The Examination Board (Jury) and chair will be set up – by mutual agreement between the partner institution (Western and ULB) – by Western and sent to the Université Libre de Bruxelles for the approval.

Article 15.

The doctoral dissertation will be written in French and must include an abstract in English. The examination will be held in French.

Article 16.

The Single public defense (viva voce) will be recognized by both partner institutions.

A private defense will be first held at Université Libre de Bruxelles – by **videoconference**

The public defence will be held at **Western – by videoconference (cf. article 17)**.

Before the defence, the doctoral candidates will be required to present their work at a public seminar at the Université Libre de Bruxelles.

Article 17.

The parties agree on the following regarding expenses for the thesis jury.

La Faculté de Philosophie et Lettres at the Université Libre de Bruxelles (ULB) does not support travel expenses outside the European Union ; the defense will be held by videoconference unless the members of the ULB can find financial aid.

Article 18.

In conformity with the regulations in force within each institution and on the basis of a favourable report from the jury, the two partner institutions will each award a Doctorate degree to the successful candidate via two separate diplomas:

Docteur en langues, lettres et traductologie de l'Université libre de Bruxelles

and

Doctor in Philosophy from the University of Western Ontario ("Western").

At Bruxelles, the diploma, and at Western, the official transcript, will specify the partnership with the partner institution and the joint supervision of the thesis, in conformity with regulations in force within each institution.

SECTION 5: SPECIAL CONSIDERATIONS

Article 19.

The candidate must agree to respect the regulations in force in each institution concerning the submission, the registration and the reproduction of the doctoral dissertation.

Without prejudice to any pre-existing confidentiality or other obligation, the candidate must agree to grant to the Université Libre de Bruxelles and Western, a royalty free, worldwide, non-exclusive licence, to archive, reproduce and communicate the thesis through its institutional depository.

The publication, exploitation and protection of the subject of the thesis and the results of the research are managed by the two partner institutions, in conformity with their relevant national legislation.

Article 20.

Any change to provisions agreed in the present agreement will require an additional clause to the present agreement.

Article 21.

If there is a disagreement between the Parties on the interpretation of this Agreement or any aspect of the performance by either Party of its obligations under this Agreement, representatives of the Parties, shall, within ten (10) business days of receipt of a written request from the most diligent Party to the other, meet to try to resolve the disagreement in good faith.

If resolution does not occur within seven (7) business days after the initial meeting, the matter shall be escalated for determination by the duly authorised representatives of both Parties who shall undertake best efforts to resolve the matter themselves in good faith within an additional fourteen (14) business days.

Article 22.

This Agreement becomes effective as from the date of signature by the last duly authorised representatives of each Party and by the doctoral candidate and shall remain in full force and effect until the end of the academic year when the thesis is defended.

Each Party is authorised to terminate the Agreement every year provided that such decision is duly motivated. The Party which takes the initiative thereof undertakes however to host the doctoral candidate to carry on their research work.

The doctoral candidate can also terminate this Agreement by sending a letter to the person in charge of joint PhD agreements in the relevant institution. A copy of said letter shall be sent to the person in charge of joint PhD agreements in the other institution.

Executive Summary

The Ivey Business School has a range of successful professional and research-based graduate programs. The reviewers were particularly impressed with the faculty's commitment to teaching excellence through the case method, the range of academic and career-related services available to students, and the quality and experience of the student body. The new Ivey building provides exceptional teaching resources, student work space, and technological supports.

The challenges facing Ivey's graduate programs are program-specific and are outlined below.

Significant Strengths of Program:

- In all programs, Ivey places emphasis on high-quality teaching. The faculty are enthusiastically committed to spending the time needed to properly employ the case method.
- Students receive exceptional support and training in career-building, self-marketing and recruitment. They are supported by a highly professional staff and alumni mentors.
- The Toronto EMBA program provides intensive training to experienced professionals from a diversity of backgrounds, and was especially praised for its international field experiences.
- PhD students receive training in both research methods and teaching. This increases their competitiveness when seeking academic positions after graduation.

Suggestions for Improvement & Enhancement:

- Ivey has experienced declining enrolment in the MBA and EMBA (Hong Kong) programs, which appears to be consistent with trends across North America. The Faculty will need to review the long-term sustainability of the Hong Kong program in its current form.

- The objectives of the MSc were not entirely clear: some described it as a pre-experience program for non-HBA graduates, and others described it as a pre-PhD program. This has the potential to create mixed expectations among students.
- The MBA and EMBA programs do not currently have measurable rubrics or independent scoring methods for assessing “leadership essentials.” Graduate faculty need to develop assessment methods for these key learning outcomes.
- While minimum funding for PhD students is currently \$28,000/year, this is low compared to some comparable institutions and may affect Ivey’s ability to attract top-quality PhD students in the future.

Executive Summary

The one day visit of the review team provided the occasion for reviewers to interact with faculty members from the departments of Applied Mathematics, Computer Science, Statistical and Actuarial Sciences, and Physics and Astronomy, in addition to meeting graduate students, staff members, Assistant university librarian, and representatives of SGPS. The conversations revealed useful information about what makes the Program in Scientific Computing, in the reviewers' words, a "value add" program, and pointed out ways in which the program could be further strengthened. Overall, the reviewers support the continuation of this program, identifying it as "well-structured and innovative," timely, and providing "incremental value" to students getting trained in the field of Scientific Computing. Below are some points that external reviewers identified as the program's strengths while simultaneously offering suggestions for improvement.

Significant Strengths of Program:

- High competence of faculty in research, teaching, training of students, and strong record of publication
- Collaborative nature of the program offers an innovative approach to the teaching of scientific computing at the graduate level
- Learning outcomes are well expressed in the brief as well as in course descriptions
- Program's requirements are clearly articulated, both in the brief and in the course structure, and the course structure is appropriate
- Timeliness of the program and its ability to bridge a severe training gap at the undergraduate level, a gap based on limited competency in scientific computing in most undergraduate curricula in Canada
- High quality of students
- Excellent resources that include the Sharcnet facility, library materials, study rooms, group workrooms, and seminar practice rooms

Suggestions for improvement & Enhancement:

- While course learning outcomes are defined, identifying concrete learning outcomes for the program would be useful (for example, learning how to program, formalizing knowledge of numerical techniques, innovative thinking, gaining formal credibility on their diploma). Some clarification as to how specific courses measure these learning outcomes is recommended
- Clarification regarding requirements for the seminar course and Sharcnet workshop would be helpful
- The Sharcnet element of teaching is an exciting component of the program and should be both promoted and further expanded to better address the program's needs in terms of consolidating students' experience and skills

- Scientific Computing is relevant to many disciplines that are not currently included within the scope of the program. Broadening participation, and course offerings, to include appropriate aspects of biology, biochemistry, health sciences, finance, computer science, statistics, and “big data” would help with interdisciplinary outreach and would increase program enrolment.

First preference will be given to students who are participating in the School Within A University (SWAU) program offered in partnership between Western University and the Thames Valley District School Board. Second preference will be given to students who are participating in other programs offered by the Thames Valley Alternative Secondary School (TVASS) such as School Within a College (SWAC) or Reconnect. The TVASS Award Committee will provide a list of eligible students to the Office of the Registrar (SWAU listed first). Final selection of recipients will be made by the Office of the Registrar. The award is continuing for up to four years provided the recipients continue to be registered in 3.5 or more courses. The Student Success Centre will match recipients with a mentor every year as part of their Leadership and Mentorship Program. Candidates are invited to complete the online Admission Bursary application available through the Office of the Registrar website by June 1. If there are insufficient candidates from the School Within A University program and other TVASS programs, available funding will be disbursed to full-time undergraduate students at Western University or its affiliated colleges who are entering first-year of any faculty and who have graduated from a secondary school in Ontario within one year of admission to Western University, based on financial need. The award will continue for up to four years. Retention will be based on continued demonstration of financial need and continued full-time enrolment. Applications are available through the online Admission Bursary application available through the Office of the Registrar website and must be submitted by June 1. If a recipient does not qualify for renewal, a replacement recipient will not be selected. The unused funds will remain in the spending portion of the endowment to support additional awards in future years.
